^{*}The Department's Student Dress Code policy on Developing and Reviewing Dress Codes requires school councils to decide annually whether or not amendments or a full review of the dress code is required.

PURPOSE

The purpose of the Student Dress Code is to outline Greater Shepparton Secondary College requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code was originally developed and endorsed by the four (4) secondary School Councils in Shepparton and Mooroopna to ensure that it respects the rights of individual studentswhilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- promote a sense of identity and pride, cohesion and good order in the school
- allow all students to feel equal
- prevent bullying and competition on the basis of clothing
- ensure students' appearance reflects the expectations of their school community
- enhance the profile and identity of the school and its students within the wider community
- strengthen the spirit of community within the school
- enhance individual student safety and group security
- ensure all students are dressed safely and appropriately for school activities
- prepare students for the expectations of workplaces
- encourage students to present themselves appropriately for a particular role.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

UNIFORM AND APPEARANCE

The full list of Greater Shepparton Secondary College compulsory school uniform items are available at Appendix A to this policy.

Students can wear any uniform item regardless of gender.

General appearance

While at school, travelling to or from school or participating in school activities, Greater Shepparton Secondary College students must comply with the following:

- Uniforms must be clean and in good repair
- Uniforms should be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden.
- Studs, sleepers and watches are the only acceptable jewellery
- Any make up or nail polish must be neutral tones only

Sun safety

As we are a secondary school, we expect students to take responsibility for being sun smart by wearing a school hat during outdoor activities in term 1, term 4 and on high UV days or staying in the shade, if they are not wearing sunscreen.

Hats are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible.

Jewellery, nails, hair accessories, hat cords and similar items that interfere with students' ability to engage with school activities safely and fully are not permitted.

Students who wear braids or locs may wear them loose, except for applied technology classes where hair should be tied back for safety purposes.

While the Uniform item list specifies items for summer and winter uniform, students are able to wear summer and winter uniform items all year-round.

PURCHASE OF UNIFORMS

Uniform items can be purchased from the local uniform shop providers. Permitted non-branded uniform items can also be purchased from department stores.

Greater Shepparton Secondary College offers second hand uniform items directly from the college, for further information contact the school on 03 5891 2000.

Support for families experiencing difficulty

Please contact the Principal, or Wellbeing Leader to discuss support that we may be able to provide to families experiencing difficulty meeting uniform costs, including information about eligibility for uniform support through State Schools' Relief. Greater Shepparton Secondary College will ensure that this Student Dress Code is communicated to all families and students through our website, Newsletter and Compass. We will assist students who may be experiencing difficulties complying with this policy where possible.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, a text message will be send home at the end of each day on non compliance with the uniform policy. If non- compliance with the dress code becomes a continued occurrence, the Principal will be informed and a phone call home may be required. In this event, the school will continue to work with the student and family to support compliance.

Measures taken by Greater Shepparton Secondary College to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

EXEMPTIONS TO STUDENT DRESS CODE

We recognise that there may be situations where the application of this dress code may affect students unequally.

Students and their parents or carers may apply either in writing to the Principal for an exemption to this Student Dress Code if:

- an aspect of the code:
 - prevents students from being able to attend school or participate in school activities on the same terms as other students because of the <u>personal characteristics referred to in human rights and anti-</u> discrimination requirements
 - offends a religious belief held by the student or parents/carers
 - prevents students from complying with a requirement of their religious, ethnic or cultural background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or the parents/carers can demonstrate financial hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- guarantee that issues of a personal nature revealed to substantiate the request will be strictly confidential
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties, including providing advice about support with meeting uniform costs.. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

CONCERNS ABOUT THIS STUDENT DRESS CODE

The community will be given advance notice of the consultation process and timelines. The consultation will be open for at least 2 weeks.
